

A summary of responses to Cheshire East Council's

School Transport Policy Consultation 2023







Executive Summary

Introduction

Between 15 November and 22 December 2023 Cheshire East Council consulted on several proposed changes to its school transport policies. These changes were proposed to enable the council to continue to deliver its statutory duties in a cost-effective manner, at a time when savings are needed across all services run by the council.

In total there were 444 consultation responses, including 439 online survey responses and 5 email responses.

A large majority of survey respondents, 88%, were parents or carers of a child or young person who uses school transport.

Survey respondent feedback on the proposed changes

Proposal to make the application process "digital by default"

63% of survey respondents supported the proposal to make the application process "digital by default", 17% opposed this.

Those expressing opposition to this proposal felt there should be equality of access, that some don't have internet access, are not able to use computers, and require support when completing application forms.

Proposal to make people reapply for travel support whenever there is a change in the phase of education

29% of respondents supported the proposal to make people reapply for travel support whenever there is a change in the phase of education, 54% opposed this.

Those expressing opposition to this proposal felt it was unnecessary and a waste of time, that needs are lifelong, that this adds extra stress for parents and creates more paperwork for the council. They felt people should only have to reapply under certain conditions e.g. when moving house or changing schools.

Proposal around post-16 travel support

49% of survey respondents felt the council should "continue with the current parental contribution and increase the charge" for travel support for post-16 students.

25% felt the council should "only offer a personal travel budget, based on individual home to college mileage, for all eligible students to enable parent/carers to make their own travel arrangements".

Just 3% felt the council should "end all travel support for post-16 students".

Survey respondents felt that as children have to remain in education until age 18, that school transport support should continue until then. Many also felt this support should be free instead of being charged, especially for those in rural areas, or for those a long way away from the students setting. Some suggested that if support is stopped, or increased significantly, some would not be able to continue to send their child to school.

Large proportions of survey respondents (between 71% and 79%) felt the following 4 of the exceptions for post-16 travel support should be considered:

- If a specialist vehicle is required for accessibility
- When students medical needs would generally require a Passenger Assistant
- Only if most suitable appropriate placement is a long distance from home
- When family income is low

A large proportion of survey respondents, 65%, felt that when dealing with increases in charges for post-16 travel, "charges should be increased and reviewed every 2 years". Just 9% felt "charges should be increased and adjusted by inflation each year and backdated to 2018".

Proposal relating to spare seats and charging

66% of survey respondents felt the spare seat scheme should continue, even as a non-statutory provision, 10% disagreed.

42% of survey respondents agreed that charges for spare seats should be increased and standardised in-line with other school transport charges, 30% disagreed.

A large proportion of survey respondents, 62%, felt that when dealing with increases in charges for charges for spare seats, "charges should be increased and reviewed every 2 years". Just 9% felt "charges should be increased and adjusted by inflation each year and backdated to 2018".

When asked to comment respondents felt spare seat provision should continue with no extra charge for those that need it, and the consequences of removing or increasing charges for this service would be that some would not be able to continue to send their child to school.

Proposal to collect payments for school transport by regular direct debit

75% of survey respondents supported the council's proposal to collect charges monthly by direct debit, 7% opposed this proposal.

Proposal to remove travel assistance for under 5-year-olds

31% of survey respondents supported the removal of travel support for under 5 year olds, 48% opposed this proposal.

Those that opposed this proposal suggested that transport should be provided regardless of age, and that pre-school starts as early as 3 and 4 years old. They felt this proposal would be discriminatory and inappropriate, and that early years education would be impacted if these children cannot get to their preferred setting.

Some were concerned about children under 5 using transport without parent/carer assistance.

Proposal to update policies around school transport eligibility

Some survey respondents expressed opposition to the council changing school transport eligibility criteria based on parental placement preference, feeling that parents/carers know better what a child needs than the Local Authority. They felt this policy change could impact on the education of the child and the ability for children to go to school.

Some felt that Foster Carers should be treated the same as parent/carers, and that the proposal discriminates against foster children, while others felt foster carers are paid a salary and should cover the costs of transport.

General improvements to travel to school

When survey respondents were asked whether they agreed or disagreed with a list of suggested ways of improving school transport:

- 83% agreed with "encouraging transport operators to introduce more bus services where there is demand, 8% disagreed
- 72% agreed with "working with schools / colleges to enable them to increase capacity within their own fleet of vehicles", 13% disagreed
- 51% agreed with "developing a programme for independent travel training",
 22% disagreed

Final comments

Final comments from survey respondents about the consultation included that:

- This service is vital and the council should look elsewhere for savings, that the council should "leave us alone"
- SEN children's needs must be the priority, and not saving money
- Central government should be lobbied for extra funds

• The removal of services, or increases in charges, could have significant negative impacts on the lives of the children and families who will be affected

Finally, survey respondents suggested the service needed to be made more efficient.

Email feedback

5 emails received during the consultation covered the following topics:

- Happy with current arrangements
- Believes the cost of school transport is currently too high and should be reduced
- Queries what the implications of the proposals are
- Feels there are a lack of safe walking routes to the nearest school
- Expresses the difficulty in getting spare seats

Conclusions

It is clear from consultation feedback that any changes to this service may have an impact on some families living in Cheshire East who rely on school transport assistance.

Proposals that were well supported

Proposals put forward during the consultation which seemed to be well supported included the proposal to make the application process "digital by default" (63% support, 17% oppose), and the proposal to collect payments for school transport by regular direct debit (75% support, 7% oppose).

Though these proposals should strongly be considered for adoption, they should be implemented with regard to those who may be adversely affected by these changes, particularly those that don't have internet access, or those that struggle to use computers without assistance – mitigations must be put in place for these people.

Proposals which were strongly opposed

The proposals that seemed to be strongly opposed included the proposal to make people reapply for travel support whenever there is a change in the phase of education (29% support, 54% oppose), and the proposal to remove travel assistance for under 5-year-olds (31% support, 48% oppose). Consideration should be given as to whether these proposals are taken forward.

There also seemed to be opposition to proposals to change policies around school transport eligibility based on parental preference for school setting, and arrangements for Foster Carers, therefore any proposed changes should ensure that they are compliant with latest guidance.

Proposals with mixed results

A large proportion of respondents indicated that they felt post-16 travel support should continue, particularly given some students have to remain in education until the age of 18. Furthermore, a larger proportion of respondents felt the council should continue with the current contribution and increase the charge, rather than only offering personal travel budgets, but there was significant support for both options.

A large proportion of respondents also felt the spare seats scheme should continue, though there were mixed results on whether charges for spare seats should be increased and standardised in-line with other school transport charges.

For both these proposals some respondents felt they should be provided free, with no charge at all. Of those who felt a charge was acceptable, large proportions of respondents for both these proposals preferred charges being increased every 2 years, rather than being backdated to 2018.

Introduction

Purpose of the consultation

Between 15 November and 22 December 2023 Cheshire East Council consulted on several proposed changes to its school transport policies.

These changes were proposed to enable the council to continue to deliver its statutory duties in a cost-effective manner, at a time when savings are needed across all services run by the council.

The full material that was consulted on is outlined in Appendix 1.

Consultation methodology and response

Consultation responses were invited from anyone who wished to respond – the consultation was not run as a referendum nor as a statistically robust random sample survey. Results should therefore be treated with caution and should be interpreted within the context in which they were gathered.

The consultation was promoted through direct contact via email with all those who might be affected by proposals. Responses were also invited from anyone else who wished to respond.

In total there were 444 consultation responses, including:

- 439 online survey responses
- 5 email responses


Reading this report



About the survey respondents

A large majority of survey respondents, 88%, were parents or carers of a child or young person who uses school transport. Percentages in the chart below may not add to 100% as respondents could choose as many answer options as they wished to.



Of those responding on behalf of children and young people that use school transport, 55% were responding on behalf of a young person in secondary school who receives free or subsidised travel from the council.




Proposal to amend the application process

Support and opposition to proposals

63% of survey respondents supported the proposal to make the application process "digital by default", 17% opposed this.

29% of survey respondents supported the proposal to make people reapply for travel support whenever there is a change in the phase of education, 54% opposed this.



Comments on proposals to amend the application process

Survey respondents were asked for comments about the proposals to amend the application process.

In total, 215 comments made in response to this question have been analysed, and these comments have been grouped into categories and summarised below.



Proposal around post-16 travel support

What should post-16 travel support look like?

When survey respondents were asked how the council should continue offering travel support for post-16 students:

- 49% felt the council should "continue with the current parental contribution and increase the charge"
- 25% felt the council should "only offer a personal travel budget, based on individual home to college mileage, for all eligible students to enable parent/carers to make their own travel arrangements"
- 3% felt the council should "end all travel support for post-16 students".



23% of survey respondents gave an "other" answer to this question, with a total of 90 other alternatives being suggested. These other suggestions have been summarised in the below table:



Post-16 travel support exceptions


Large proportions of survey respondents felt that all 4 of the exceptions for post-16 travel support should be considered:

- 79% felt the exception "If a specialist vehicle is required for accessibility" should be considered
- 78% felt the exception "When students' medical needs would generally require a Passenger Assistant to be provided" should be considered
- 71% felt the exception "Only if most suitable appropriate college / school / placement is a long distance from home" should be considered
- 71% felt the exception "When family income is low" should be considered



Dealing with increases in charges for post-16 travel support

A large proportion of survey respondents, 65%, felt that when dealing with increases in charges for post-16 travel, "charges should be increased and reviewed every 2 years". Just 9% felt "charges should be increased and adjusted by inflation each year and backdated to 2018".



Comments on proposals relating to post-16 travel support

Survey respondents were asked for comments about the proposal to amend travel support for post-16 students.

In total, 190 comments made in response to this question have been analysed, and these comments have been grouped into categories and summarised below.




Should the spare seat scheme continue

66% of survey respondents felt the spare seat scheme should continue, even as a non-statutory provision, 10% disagreed.




Dealing with increases in charges for spare seats





31% of survey respondents supported the removal of travel support for under 5 year olds, 48% opposed this proposal.

Survey respondents were asked for comments about the proposal to remove travel support for under 5 year olds.

In total, 119 comments made in response to this question have been analysed, and these comments have been grouped into categories and summarised below.



Proposals put forward during the consultation which seemed to be well supported included the proposal to make the application process "digital by default" (63% support, 17% oppose), and the proposal to collect payments for school transport by regular direct debit (75% support, 7% oppose).

Though these proposals should strongly be considered for adoption, they should be implemented with regard to those who may be adversely affected by these changes, particularly those that don't have internet access, or those that struggle to use computers without assistance – mitigations must be put in place for these people.

Proposals which were strongly opposed

The proposals that seemed to be strongly opposed included the proposal to make people reapply for travel support whenever there is a change in the phase of education (29% support, 54% oppose), and the proposal to remove travel assistance for under 5-year-olds (31% support, 48% oppose). Consideration should be given as to whether these proposals are taken forward.

There also seemed to be opposition to proposals to change policies around school transport eligibility based on parental preference for school setting, and arrangements for Foster Carers, therefore any proposed changes should ensure that they are compliant with latest guidance.

Proposals with mixed results

A large proportion of respondents indicated that they felt post-16 travel support should continue, particularly given some students have to remain in education until the age of 18. Furthermore, a larger proportion of respondents felt the council should continue with the current contribution and increase the charge, rather than only offering personal travel budgets, but there was significant support for both options.

A large proportion of respondents also felt the spare seats scheme should continue, though there were mixed results on whether charges for spare seats should be increased and standardised in-line with other school transport charges.

For both these proposals some respondents felt they should be provided free, with no charge at all. Of those who felt a charge was acceptable, large proportions of

respondents for both these proposals preferred charges being increased every 2 years, rather than being backdated to 2018.

Happy with current arrangements. Has a complaint about too many students being transported in one taxi.

Good morning.

My son travels by taxi from [redacted] to [redacted].

I am generally very happy with the arrangements apart from one very important issue. 4 students travel in a saloon car which means that 3 are cramped in the back seat. [Redacted], my son, is quite stocky so feels squashed in the back seat. He also gets verbal abuse from another student if he is using his iPad to draw as his elbow digs into her. [Redacted] often needs to draw to regulate his behaviour before college.

I really don't think that it is appropriate for 4 SEN students to travel in a saloon car on such a long journey.

Summary of content:

Believes the cost of school transport is currently too high, and should be reduced. Suggests setting up more cycle ways and cycling networks, with cycle leaders in place, to provide a greener and more economical travel alternative.

Full Email:

In response to the recent email I would like to make some comments.

The consultation should look to reduce the cost for families. It currently costs me £1400 to send my children to school!

Those who don't live close to a high school are in essence penalised financially!

My children attend [redacted], yes [redacted] is our closer school but we are still over 3 miles from there and would not have been accepted as my children did not go to a feeder school – something we did not consider when applying for primary schools!

My children and their friends who also get the bus to [redacted] are very capable of cycling they previously cycled to [redacted] Primary from [redacted] on a regular basis, but the [redacted] is very muddy and unlit in the direction of [redacted] unlike the other way which has lights and is well surfaced.

I would love Cheshire east to put some resources together to improve cycle to school access especially [redacted] - [redacted] - [redacted]. It would tick environment boxes, health boxes and reduce financial costs. Even better would be the employment of a responsible adult, just like a bus driver is required to drive the bus – how good would it be to have a group leader to supervise a mass cycle to school along [redacted]. It could have set collection points at set times. A bus driver without the bus – and all the associated environmental and financial costs.

If you are not sure about this why not run a pilot scheme or reach out to discuss further. I know a lot of children attending (past and present) are pro cycling and green travel as we set up our own carbon free commute group. Wouldn't it be good if Cheshire east council, parents and high schools could set up a similar scheme, children are the future and if we normalise cycling to school this will be something that goes forward into future generations.

If you are looking to make changes please think outside the box and consider the above changes – they are a little bit different but really solve a lot of the problems.

My [redacted] has managed to get a spare seat even though this was challenging to organise and expensive.

My issue with paying is firstly because she has to remain in education as per government rules and is attending her feeder school – we haven't chosen to move her – I believe if it is expected children should stay in full time education then transport should be provided and paid for by the councils.

I am aware any changes will be too late for us as my youngest is [redacted] this school year but hope it changes for future families.

Cheshire East Council is proposing a number of changes to <u>its school</u> transport policies.

The revised policies will reflect <u>updated Department of Education "Travel to school for children of compulsory school age" guidance</u>. We are also looking at how we can simplify our processes for the mutual benefit of both the council and its residents.

Reasons for the proposed changes

Free travel to school is a valuable service for many families, but budget pressures mean that the council often has to make difficult decisions about how to make best use of the limited resources available to them. Like many councils across the country, Cheshire East Council currently spends a significant amount of its budget on providing transport for children and young people. As these costs are expected to continue to rise, it will adversely affect the level of service we are able to provide to children and their families. Many school travel charges have not been reviewed or been subject to inflationary increases since 2018.

Therefore, changes are required to enable the council to continue to deliver its statutory duties in a cost-effective manner. We have already made some changes, including increasing the value of the personal travel budget and simplifying the process for parents who choose to take this option. This increase has been positively received by parent/carers.

Proposal to amend travel support for post-16 students

Travel support for post-16 students is discretionary and therefore the council can choose how to support these children and young people.

Currently, parents / carers of post-16 students in Cheshire East can apply for travel support and, if eligible, may have to make a financial contribution towards any transport provision. This is currently set at £450 per year, which equates to approximately £2.50 per day. This is a small proportion of the average cost to the council, which is currently £9,840 per post-16 student per year.

Current charges have not been reviewed or been subject to an inflationary increase since 2018, and as the provision of travel support for post-16 students is discretionary, the council is proposing to change its policy for these students to one of the following options:

- Continue with the current parental contribution and increase the charge
