Thank you. On behalf of Peel Land and Property I confirm this is the wording we have agreed with the Council.

I note the Council's position is still that the site should be considered through the medium of a planning application rather than a positive allocation because of the uncertainty around the application of policy ENV13 in relation to housing development.

Peel would respond by pointing out that:

- 1. the policy provides for this and requires a demonstration that any proposals would be acceptable in terms of ENV13 and
- 2. In the original publication Plan the site was allocated in similar terms to that now proposed (but including, at that time, a specific amount of housing) since which ENV 13 has been revised to be less onerous.
